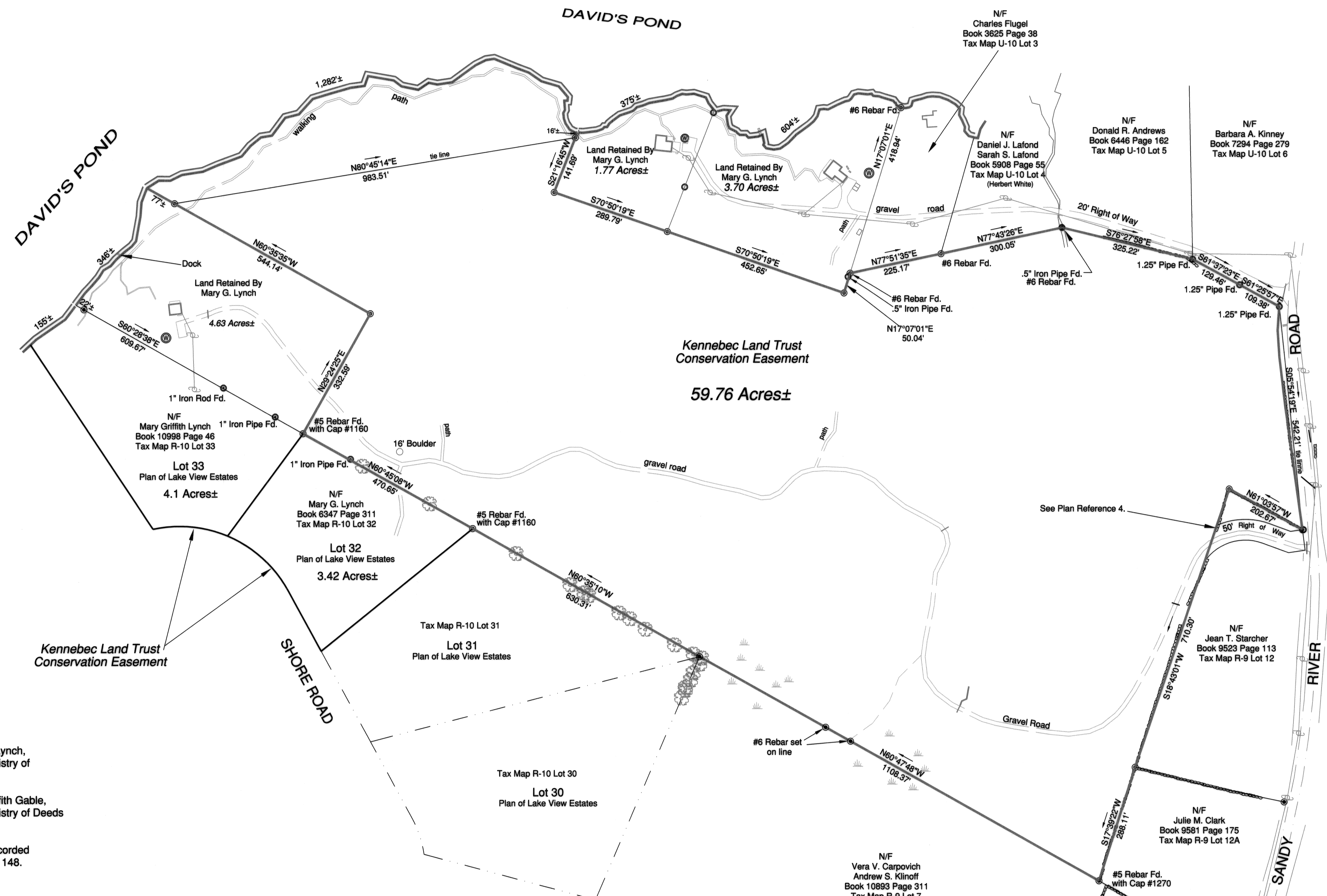

Magnetic North 2012

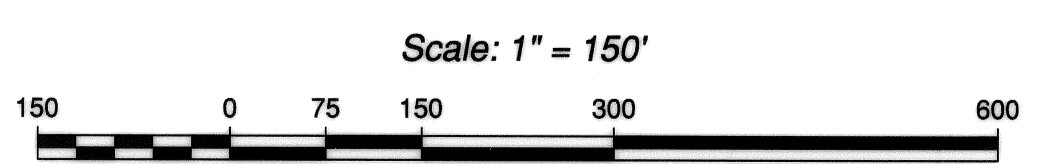
